#### **Full import declaration required**

If the goods are the outcome of a deceased estate

• B534

- Statement on statutory declaration advising that goods are not for re-sale, the estimated value of the goods and the reason why you are receiving the goods
- Copy of the Will and a copy of the Death Certi cate OR a letter from the Executor and a copy of the death certi cate
- 100 points Evidence of Identity
- Import Instruction
- Alcohol and tobacco listing (if applicable)
- Payment of Quarantine inspection Fee and Customs Entry charges
- Itemised list with values

Motor vehicles over 30 years old	<ul> <li>Vehicle Import Permit (must be obtained prior to shipping)</li> <li>Bill of Lading</li> <li>Registration papers from country of origin</li> <li>Cost of Freight and insurance premium paid for marine transit insurance (copy of invoice preferred if possible)</li> <li>Motor vehicle valuation may be done. Only if Customs directs OSS to do it.</li> <li>Passport copy</li> <li>Motor Vehicle Instruction Sheet</li> </ul>	DUTY FREE IF NO MODIFICATIONS GST APPLIES

Motor vehicle purchased via internet Owner has not travelled and vehicle not owned and used for 12 months or more.	<ul> <li>Vehicle Import Permit (must be obtained prior to shipping)</li> <li>Bill of Lading</li> <li>Original purchase invoice noting price paid</li> <li>Cost of freight and insurance premium paid for marine transit insurance (copy of invoice preferred if possible)</li> <li>Passport copy</li> <li>Motor Vehicle Instruction Sheet + Asbestos Sheet</li> </ul>	DUTY AND GST APPLY

Golf buggies Commercial Broker Entry	<ul> <li>Vehicle Import Permit (must be obtained prior to shipping)</li> <li>Purchase Invoice</li> <li>Bill of Lading</li> <li>Cost of Freight and insurance premium paid for marine transit insurance (copy of invoice preferred if possible)</li> <li>Passport copy</li> </ul>	DUTY AND GST APPLY
Mobility Wheelchairs Commercial Broker Entry Mobility Wheelchairs Cont	<ul> <li>Must be self propelled</li> <li>Can only accommodate one person</li> <li>Are designed so as not to exceed 10km/h on level ground</li> <li>Have more than 2 wheels</li> <li>Have an unladen mass not less than 40kg</li> <li>Vehicle Import Permit (must be obtained prior to shipping)</li> <li>Bill of Lading</li> <li>Cost of Freight and insurance premium paid for marine transit insurance (copy of invoice preferred if possible)</li> <li>Passport copy</li> <li>Purchase Invoice</li> </ul>	DUTY FREE, GST FREE
Jet Ski Commercial Broker entry	<ul> <li>Must be owned and used 12 months prior to export and the importer is eligible to import as personal effects.</li> <li>Vehicle Import Permit – trailer only (must be obtained prior to shipping)</li> <li>Bill of Lading</li> <li>Cost of Freight and insurance premium paid for marine transit insurance (copy of invoice preferred if possible)</li> <li>Passport copy</li> </ul>	NO DUTY OR GST PAYABLE if eligible to clear as Personal Effects.  Duty and GST payable on the trailer.
